Re: Devex/Nestlé partnership – **with signatories**

Dear Kate,

We are writing to express grave concern about the upcoming Devex event, "*Nutrition and flourish: The role of nutrition in improving womens' health outcomes*," and your role as moderator.

Devex's event partner is Nestlé, which has been under intense scrutiny for decades for its exploitative marketing practices that undermine efforts around the globe to uphold the right to optimal nutrition, leading to an increase in morbidity and mortality for women, infants and young children. Indeed, in recent years Devex has provided valuable coverage of these issues including carrying [this opinion piece](#) by global expert Constance Ching on the importance of upholding and strengthening the International Code of Marketing of Breast Milk Substitutes (the Code). How can you be "the world's leading independent news organization covering global development," when you engage in such partnerships?

We are asking you to immediately withdraw as host, and for Devex to cancel this event, disentangle/dissociate with Nestlé, and commit to adhering to the Code and subsequent relevant WHA resolutions.

The event's promotion correctly states:

"Millions of women and adolescent girls across the globe struggle to access nutritious diets and essential nutrition services, exacerbating gender inequalities. Good nutrition is vital for women's health before and during pregnancy or breastfeeding, and to raise well-nourished children. Without proper nutrition, women and adolescent girls risk weakening their immunity to infections. Globally, more than 1 billion adolescent girls and women suffer from undernutrition, micronutrient deficiencies, and anemia, endangering our communities. The

gender gap in food insecurity more than doubled from 49 million in 2019 to 126 million in 2021, with COVID-19 exacerbating the situation.”

We would ask that you reach out to the IFE Core Group to open a dialogue to discuss potential next steps.
